ACT TO **SURRENDER QUITCLAIM**  $\mathbf{AN}$ AND EASEMENT **INTERESTS** OWNED BY **GOVERNMENT OF GUAM ON PRIVATE LOT NO. 238-**2A-4, SANTA RITA IN EXCHANGE FOR A GRANT FROM THE OWNER, NEW WATER AND SEWER **EASEMENTS FOR** THE **BENEFIT OF GUAM** WATERWORKS **AUTHORITY** ON THE **SAME PRIVATE** LOT AND TO ALLOW FOR THE ABANDONMENT OF UNUSABLE SEWER LINES AND CONSTRUCTION **OF** NEW WATER **AND** WASTEWATER FACILITIES.

## 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan finds that
- 3 Guam Waterworks Authority (GWA) is in need of new easements on private
- 4 property to construct new water and sewer lines and other facilities. The lots in which
- 5 GWA wishes to construct the new facilities both have existing GWA sewer lines
- 6 under them allowed by Government of Guam easements that were originally granted
- 7 for the benefit of PUAG.
- 8 The owners of Lot No. 238-2A-4, Santa Rita has executed easement
- 9 agreements that require them to grant the necessary easement to GWA in exchange
- 10 for the surrender of the PUAG easement to the lot owner.
- 11 Section 2. Surrender and Quitclaim. The twenty (20') foot sewer
- easement on Lot No. 238-2A-4, Santa Rita (formerly Agat), Estate No. 228683,

- Suburban that is owned by the Government of Guam is hereby surrendered and quitclaim to the current owner of the lot.
- Section 3. Guam Environmental Protection Agency (Guam EPA) *shall*work with Guam Waterworks Authority (GWA) to ensure regulations are followed
  to clean and mitigate the abandonment of sewer lines within said easements.
- Section 4. Severability. If any provision of this Act or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity shall not affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
